

**NOTICE OF TIMBER SALE

GENERAL INFORMATION

The Alabama Forestry Commission (AFC) offers for sale approximately 2,388 tons of pine sawtimber, 156 tons of pine pulpwood, 621 tons of mixed hardwood sawtimber, and 1215 tons of hardwood pulpwood on two tracts totaling approximately 86+/- acres. No representation is being made concerning the actual amount of timber which could be harvested from this tract. Bidders are expected to satisfy themselves as to both quantity and value of the timber before submitting a bid. By nature of this announcement, you are invited to bid on the timber described herein. All bids and terms of this sale are subject to the approval of the AFC State Forester.

LOCATION

The sale area is located at the intersection of Choccolocco Rd. and Joseph Springs Motorway in portions of Section 15, 16, & 21, Township 15 South, Range 9 East, Calhoun County, AL, as shown on attached map, on property known as Choccolocco State Forest.

DESCRIPTION OF TIMBER

This is a sale of all merchantable timber on two tracts (22+/- acres and 64+/- acres - see attached map). Both sale areas are flagged in pink. An SMZ has been flagged in blue in the southern portion of the larger tract. No trees are to be cut within this blue flagging. All roads are to be maintained, kept cleared of debris, and restored to original or better condition upon completion of logging. BMP's as described in the publication "Alabama's Best Management Practices for Forestry" are to be followed at all times.

BIDDING

Lump-sum, signed bids for both tracts together will be received until 10:00 AM on December 12, 2018, at the AFC Calhoun County office at 3985 Hwy 21 North in Jacksonville, AL, for purchase of all timber officially designated for sale, estimated as previously described. **Please use the attached bid form.** Bids should be clearly addressed to "**Choccolocco State Forest Timber Sale #19-2, 3985 Hwy 21 North, Jacksonville, AL 36265**". The envelope containing the bid should also be marked "**Sealed bid to be opened on 12/12/2018**". Bidders are invited to attend the bid opening at the AFC Calhoun County office. **Bids will also be accepted by e-mail at: steven.jones@forestry.alabama.gov.** The phone number for the county office is 256-435-6245. Bids received after 10:00 AM on December 12, 2018 will not be considered. The AFC reserves the right to reject any and all bids. All bidders will be duly notified of the bid results.

CONTRACT

A contract form similar to the one to be executed for this timber sale may be obtained by calling David Kelley at the phone number below. The length of the cutting contract will be for 12 months. If needed, a 3-month extension may be purchased for 10% of the original purchase price. The successful bidder will also be required to post a performance bond for the sale area at the time of the contract negotiations in the amount of \$5,000.


